Rules of competition

1. Collective decision of Judges is Final.
2. If there is a tie in candidates with judge decisions, judges could ask competitors to sing more songs until they are able to make decision.
3. Decision of judges cannot be appealed in any circumstances.
4. Judges are well educated in field of music and have many years of experience in music professionally in form teaching or performances.
5. Minimum age to participate will be 12.
6. There will be two categories of Male and Female.
7. Songs have to be only in Hindi.
8. To register in the competition, attach the receipt of admission ticket bought for the Sukhwinder Singh Concert on August 3rd in UNC Memorial Hall.
9. All minor participants must attach proof of age (photocopies only) in the form of birth certificate, state ID, Driver's license or passport to the application.

10. FIRST ROUND

- a. One Youtube Video or a weblink to video to be submitted at taalpetaal2013@gmail.com along with signed waiver form.
- b. Video should have the following
 - i. Should show full face of the singer facing the camera while singing
 - ii. Should have 1 stanza each of 3 type of songs- a dance number, romantic number and a semi-classical number.
- c. Video Link, waiver form and ticket receipt should be submitted by June 26' 2017
- d. Results of finalists(6 or less Male Singers and 6 or less Female Singers) will be announced on or before July 8' 2017.

11. Second Round

- a. This round will take place on July 23' 2017- Details will be notified after July 8th.
- b. This round will involve singing live in front of judges at a designated venue.
- c. Singers shall prepare 2 different types of songs on Karaoke track.
- d. If the candidate cannot sing because of whatever reason including sickness, he/she will be disqualified.
- e. Reporting on time for performance is very important. Non-reporting on time will be disqualification from competition.
- f. LIVESPECTRUM ENTERTAINMENT Organization is not responsible for any malfunctions that may occur with your music. Please bring two copies of your music (one for back-up).
- g. Arguing with judges on stage is not allowed. Any such behavior will disqualify from the competition.
- h. Judges will take into account the talent of singing plus the stage performance and appearance. We are looking for a singer and a performer.

- i. The decision will be made on the merit of performance of day of competition only. Previous wins or performances will not be taken into consideration.
 - j. We will be declaring Finalists - 2 Female singers and 2 Male Singers.
 - k. Winner Female and Male will be declared the Day of the Concert.
 - l. All details of the Day of Concert will be explained to the Finalists after second round.
 - m. Winner Jodi will be performing a Duet Song on the Day of the concert on the stage.
 - n. Winner Jodi will be recognized and awarded on the Day of the show on the stage.
